At that meeting, the Council reviewed Policy 5520, *Student Dress Code*; Policy 5561, *School Use of Reportable Offenses*; and Policy 5580, *Bullying, Cyberbullying, Harassment or Intimidation*. The

Council recommended minor edits to these policies, which involved the Policy Review Committee's editing conventions, ensuring consistent use of language across all of the policies, and defining additional terms.

- 3. Consideration of public comment received on May 7, 2019
  - a. Policy 1110, Publications, Radio, Television and Digital Media Policy 1200, Community Involvement

As no public comments were received regarding the revisions recommended for Policy 1110 and Policy 1200, the policies will be moved forward for third reader on June 11, 2019.

Renuka Rege, Esq., Public Justice Center, and Megan Berger, Esq., Disability Rights Maryland, were again invited to provide comments and recommendations concerning the Board's discipline policies, Policies 5550 and 5560.
